## **Become a Member**

The Haydon Bridge and Haydon Parish Development Trust was formed in partnership with Haydon Parish Council to take forward the Haydon Parish Plan 2008-2018. The Development Trust works on behalf of the local community, and is run by the Community.

The **objects** of the Company are the promotion for the benefit of the public of urban and rural regeneration in areas of social and economic deprivation and in particular in Haydon Bridge and Haydon Parish, in the County of Northumberland ("the area of benefit") by all or any of the following means:

- (a) the relief of financial hardship
- (b) the advancement of education, training or retraining, particularly among unemployed people, and providing unemployed people with work experience;
- (c) the provision of recreational facilities for the public at large or those who by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances, have need of such facilities
- (d) the maintenance, improvement or provision of public amenities;
- (e) the preservation of buildings or sites of historical or architectural importance;
- (f) the protection or conservation of the environment in particular, but not exclusively, by advancing education in issues relating to climate change and environmental issues including the production of energy from renewable sources
- (g) such other means as may from time to time be determined subject to the prior written consent of the Charity Commissioners for England and Wales.

Membership of the Trust is open to any person living or working in Haydon Parish that approves and supports the objects of the Trust\*. All Members have the right to attend and vote at the Trust's Annual and Extraordinary General Meetings, and may stand for election to the Trust's Board of Directors, which meets approximately once every 6 weeks and undertakes the general business of the Trust.

A full copy of the Trust's Memorandum and Articles of Association may be inspected by contacting the Secretary.
